CLASS SYLLABUS

This course is designed to acquaint students with the U.S. legal system, especially how it relates to the regulation of business. The goal is to understand the nature and function of law, as well as to learn a bit of substantive law in some select areas. This means studying the basics of tort law, contracts, environmental law, antitrust, securities law, and a few other areas as time permits. Of course, we cannot comprehensively cover all or even one field of law in a course such as this. This is an introductory course that serves as the foundation for your further legal studies.

You are expected to read *all* assigned chapters and cases from the text *before* class! Please feel free to raise questions as discussion is always welcome. In fact, some classroom participation is *required* of all students. You will be asked to "present" one case during the semester. This involves reading your assigned case extra carefully and presenting to the class a brief description (about 5 minutes) of the facts and legal issues. Attendance: Students *must* attend at least 70% of classes to receive credit! Attendance will be taken at each class.

Text: Henry R. Cheeseman, *Business Law: Legal Environment* (Prentice Hall, 8th edition). This is a one-volume hardback edition. There also is an optional study guide that may be useful to some students. **Note:** The text is used in ACCT 351, so keep it for next semester and reviewing for the CPA exam! Casebook: This is an online collection of cases from which we will read selections during the semester. Do not print out the whole document! Instead, print out the assigned cases as we go along. Legal Research: Cases and other legal materials can be found by using the online research service "Lexis/Nexis." Lawyers and researchers use this research tool, which is available for free through our library. Lexis (the law database) can be reached at the library homepage: http://www.lib.udel.edu/ Under "Databases" plug in "Lexis/Nexis Academic." Go into this database and click on the library "US Legal" (on left-hand margin). Here you will find libraries for "Federal and State Cases," "Federal and State Statutes, Code, and Regulations), "Tax Law," and "Law Reviews."

Exams & Grading: There will be two exams in class during the semester and a non-cumulative final exam. Each of the three exams is worth 30% of your grade. Class participation will count for the remaining 10% of your grade. (Warning: Failure to show up to class to present your case will result in a failing grade in participation! Likewise, if you are not prepared to discuss the readings in class, I will lower your grade.) Grading will use the plus/minus system. Make-up exams will be permitted *only* under compelling of circumstances and *only* with my prior permission. Otherwise, make-up exams will be given during finals week. The grading scale is:
