BIOGRAPHICAL PROFILE

Daniel Rich is University Professor of Public Policy in the Biden School of Public Policy and Administration and Director of the Community Engagement Initiative at the University of Delaware. He has served on the faculty since 1970.

In 2009, Dr. Rich was the recipient of the University of Delaware's Medal of Distinction and was recognized by the Unidel Foundation with the establishment of the Dan Rich endowed chair in energy. The university established the Dan Rich doctoral dissertation prize. In 2016, he as inducted by Governor Jack Markell into the Order of the First State. In May 2017, he received the John Taylor award for educational leadership from the Delaware State Chamber of Commerce. He has received the Legacy Laureate Award from the University of Pittsburgh, the distinguished alumni award from the University of Pittsburgh Graduate School of Public and International Affairs, and the Muriel L. Gilman Award from Children and Families First.

From 2001-2009 Dr. Rich served as University Provost. As chief academic officer he was responsible for the administration of all programs of instruction, research, and service, and for facilitating the success of the University's 1,200 faculty and 20,000 students. From 1996-2001, he served as founding dean of the College of Human Services, Education and Public Policy, and from 1991-1996, as dean of the College of Urban Affairs and Public Policy at the University of Delaware.

An elected fellow of the American Association for the Advancement of Science, he served for a decade as visiting professor at the University of Strathclyde in Scotland and has been a senior research associate in the University's Center for Energy and Environmental Policy since its inception in 1980. He serves as a member of the University's Institute for Public Administration, the Delaware Environment Institute, and the Science, Ethics and Public Policy Program.

A recipient of a University of Delaware excellence-in-teaching award, Dr. Rich teaches courses in public policy and management and has supervised numerous doctoral dissertations, master's theses, policy briefs, and management papers. His research has focused on education policy, urban policy, energy policy, and science and technology policy. His publications include 13 books and edited volumes, and more than 100 articles, monographs and professional papers.

Dr. Rich serves as Policy Director of the Wilmington Education Improvement Commission which advises the Governor and General Assembly on strengthening public education in Wilmington and on addressing the needs of all Delaware schools with high concentrations of low-income students. He has served as chair of the Delaware Early Childhood Council, as a leader of the Vision 2015 education reform effort in Delaware, and a Delaware Commissioner to the Education Commission of the States. His public and professional service contributions include a variety of appointments in support of preK-12 education and higher education. He has served on the Boards of the Delaware Public Policy Institute, Nemours Health and Prevention Services, and the University of Pittsburgh's Graduate School of Public and International Affairs.

He received his Ph.D. from the Massachusetts Institute of Technology (1971), his M.P.I.A. from the University of Pittsburgh (1967), and his B.A. from Brooklyn College of the City University of New York (1964).

Dr. Rich was born in New York City on June 1, 1943. He married Nancy S (Johnson) Rich on August 20, 1966. They have two children, Jennifer Boaz and Andrew Rich, and two grandchildren, Emma Baz and Aidan Boaz.
