# What to know before your child's vaccination appointment...?

Before your child's appointment, we would like to share some information to best prepare you and your child.

Please make sure your child is wearing a t-shirt under a zipper type jacket or easily removable outer layer.

If you or your child needs to use the restroom, please make sure to do so before the appointment begins.

### THERE WILL BE THREE STATIONS:

- Check in
- Administration
- Waiting area

### FOR THE CHECK IN STATION:

- We ask that you bring the vaccine consent formed already filled out. If you forget the form, we will have plenty of blank forms at the clinic.
- We will ask that the parent or guardian produces a <u>Driver's License or Photo ID</u>
- We will also be asking for a <u>Medical and/or Prescription insurance for the child</u>.
  - $\circ~$  It is OK if there is none, the vaccine is FREE.
  - **There is NO CHARGE to the patient**, as a Pharmacy provider we submit to the insurance only for a medication administration fee that helps to offset our pharmacy labor.
- We will ask that the child and the parent/guardian please wear a mask during the full duration of their time at the clinic
- We will provide a QR code to access the Emergency Use Statement of the Pfizer Pediatric formulation. We will also have some paper copies available.
- If the parent/guardian does not know the exact weight of their child, we will have them step on a scale to be weighed to identify (in case of emergency) which Epinephrine (EpiPen) should be used.
- We will provide the Vaccine Record Card in the Child's name

### FOR THE ADMINISTRATION STATION:

- DE Licensed Pharmacists will be providing the vaccines today wearing KN-95 face masks and gloves.
- If you have any questions, Pharmacists will be able to provide a full counsel of the side effects and what to expect.
- Pharmacists will identify if the child must wait 15 or 30 minutes in the waiting area after vaccination
  - 15-minute wait time is assigned to any child without an allergy history
  - 30-minute wait time is assigned to any child that has an allergic history or EpiPen prescription
- Pharmacists will be providing the vaccine in the upper arm, as pictured

### Older Children

If the child is getting a shot in an arm:

- 1. Hold the child on your lap or have the child stand in front of you as you sit.
- 2. Embrace your child during the process.
- 3. Anchor both of the child's legs between your thighs.

### • <u>Pharmacists will be providing a sticker to the child at this time, as we cannot provide a</u> <u>lollipop until the waiting period is over</u>

### FOR THE WAITING AREA:

### The child will wait, sitting down, for 15 or 30 minutes after vaccination for observation

- 15-minute wait time is assigned to any child without an allergy history
- 30-minute wait time is assigned to any child that has an allergic history or EpiPen prescription

## NOTE: During this time, the child cannot eat or drink as we monitor for potential side effects. Dum Dum lollipops will be provided once the wait time is over.

Second dose appointments will be three weeks from the first dose date. You can sign up for the second dose clinic either by the QR codes that will be available at the clinic or through the confirmation email you
